neighbors who lives on Lake Anna of single-family dwellings and they indicated that they are not in favor of it. She stated two of them were supposed to speak at tonight's meeting. She said many of the neighbors expressed concern regarding maintaining the integrity of the neighborhood if this property were to be sold. She said she explained the protection that the Design Review Board approval provides, however, they maintain that it was not a good idea. She stated many of them invested in their single-family homes on Lake Anna many years ago and plan on staying in them for the rest of their lives and with that being said, no one can predict what the future holds and this rezoning opens up possibilities that some of them as Lake Anna neighbors do not want to explore, like a Circle K or a bar on the lake. She said that is why she will be voting no. Mrs. Angeloff, Mr. Palmer, Mrs. Conrad-Wokojance, Mrs. Zarle, Mrs. Coburn, Mrs. Frey, and Mr. Griffin voted "yea." Mrs. Debevec voted "no." Motion carried.

Mrs. Conrad-Wokojance stated she has encouraged the citizens of Barberton to let council know and give them direction as to what they want. She said she is disappointed in the lack of direction either way. She said she made this motion tonight because she believes it should come to a vote because she is a real proponent of the democratic system and we have these members on council who she is sure has done their due diligence to speak with their residence to inform them of their decision for tonight. She stated the only direction she has received was from the online Herald pool and it was very much against any commercial development around the lake. She said it is really hard because there is no way for further conversation and some of the other methods that are being used to contact council are quick responses of one to two sentences. She said if this piece of legislation does not pass then we could potentially have an empty building and that is a real concern as well and we do not want empty buildings that are deteriorating. She stated as a council person it is important that she knows what people think and she has said all year to contact her by phone, email or by showing up. She said she feels like she has been put in a difficult situation because the only direction she has is by the Herald pool and she does not know if it is the best decision but it is the only direction she has and that is why she will be voting no tonight. She said she is uncomfortable doing so because of the concern of an empty building but she is trying to make sure that she upholds what her citizens want. She asked everyone to further get involved and pay attention to what goes on at council because it is super important in the decisions she makes for the community. Mrs. Zarle, Mrs. Angeloff, Mr. Griffin, Mr. Palmer, Mrs. Frey, and Mrs. Coburn "yea." Mrs. Conrad-Wokojance and Mrs. Debevec voted "no." Motion carried.

Mrs. Debevec announced the Free Women's Self Defense Class sponsored by Sherri Bevan Walsh, Summit County Prosecutor will be coming to Barberton on Tuesday, November 19th from 6:00 to 8:00 P.M. She asked if you could get the word out, she would appreciate it. She said it is a great opportunity for women in the community.

Mrs. Debevec stated she help Mr. Drubel of NCS/CDS solicit on Tuscarawas for the Christmas Walk which will be held on Saturday, November 30^{th} from 5:00-9:00 P.M. She stated he is looking for volunteers and donations.

COMMUNICATION FROM THE MAYOR

Mayor Judge congratulated Mrs. Huffman, Mrs. Baker and Mrs. Low. He said they put a lot of time into the boards and commissions and it is great to have that experience and the knowledge as we move forward.

Mayor Judge announced Change for Change will be held November 22nd (4:30-7:00) at the Green Diamond and will benefit the Greynold's Classic.

Mayor Judge stated during the week he will be meeting with two different developers and also two existing businesses about possible expansions. He said he had seven different organizations in during the week which are focusing on development, economic growth and economic vitality. He said they have been very busy with a lot of attention here on the community and hopefully we can continue the momentum we have and push through this despite the loss of B&W. He said B&W is officially still scheduled to leave in October (*laughter*) and their communication is less than average but 2020 is going to be the most challenging year in the budget that he has ever seen with us loosing on of the oldest and biggest employers. He said they are doing everything they can to push through this and meeting with a lot of different organizations and businesses. He stated, unfortunately, whenever you have a development it usually takes 12-18 months to just build out and then you start realizing the tax base.

Mayor Judge stated he has been selected as the Stormwater Mitigation representative for Summit County Cities.

Mayor Judge said they have been working with FEMA to purchase homes on 14th Street. He stated 14th Street sits lower than Wolf Creek so naturally the water is going to 14th Street and it has been in the flood plane and has been flooding for over 100 years. He said he is happy to announce that almost \$600,000 will be received to purchase up to 15 homes that qualify and meet FEMA's criteria. He stated these homes will be acquired, torn down and no build zones will be placed there so they can continue to flood and it will not affect anyone. He said it is great news, it's not every house on 14th Street and they have already started to work with FEMA on 15th Street. He said as the collaboration with the Governor's Office, working with other communities and working from a regional perspective at expanding our retention pond, looking at little things to do to provide a big impact when combined together. He said he is really happy to announce that the City has received this award. He stated this alone will not solve the problem and we will never beat mother nature but the things we are doing is taking leaps and bounds to address flood mitigation from various perspectives.

Mayor Judge said as we move through the 4th quarter and into next year that his door is always open and to come in and let's talk about what they foresee or what questions they have.
