COMMUNICATION FROM THE MAYOR

The Mayor thanked Council for passing the Capital Budget Legislation this evening. As per Mr. Heitic's remarks from the Finance Committee meeting, prices are indeed rising and it could be possible that future legislation for increased spending is possible.

ARPA funds are moving forward and Council will be kept up-to-date with information. In regards to Magic Mart, City officials are continuing to meet with the developer, we do not have a Development Agreement as yet but it is in the process and Council will be kept informed.

In regards to the pot holes, this is not a problem only to Barberton. With the changing weather, the freezing and thaw really adds to the increased number of pot holes. It also hampers the City's ability to go out and fix them quickly. The trucks are set up with a blade and salt spreader need to be modified and prepared to be used for patching. It takes time. The Mayor wanted to thank Mrs. Frey for her research and getting information on a different material to use as a patch. The Mayor requested that Council members please keep putting in the e-tickets in regards to road maintenance. Council will be provided with a report on the e-tickets and the progress in completing them.

The Change for a Change event held on February 25th generated over \$550.00 for the Magical Theatre group. The March Change for a Change will be held at the VFW. Between the Change for a Change and jeans day, the City generated over \$20,000.00 for the Esther Ryan Shoe Fund and BACM over the last few years. We've done some other fund raisers over the last few years such as flag football, basketball games but we're all getting a little older so we might not be doing sporting events in the future.

In follow-up to Mr. Heitic's remarks regarding social media, negative comments by Council members, or any city employees do not help anyone. It promotes negativity and perpetuates stereotypes. The Mayor has heard from retirees, volunteers to the boards and current employees that these types of comments hurt them and they are taken as insults. If employees do not feel that they are being supported by other employees or Council, if residents do not feel that the city is supporting itself, what kind of picture is being painted? When we reach out to developers from other communities, Cleveland, Cincinnati or Columbus, they look up and check on things like social media. Why would they want to do business in a community that is perpetuating negativity? This is not singularly to City Council; we have employees who put things out there but we are a team and we are in this together and we are all working very very hard to move the community forward.

CLOSING REMARKS

President Greer wanted to thank the Mayor for looking into the e-ticket situation and providing the summary.

Mr. Griffin wanted to ask the Mayor or Mr. Hunt about the status of the property at 74 Robinson. What kind of business is it going to be as there have been workers observed renovating the building? Mr. Hunt responded that the city noticed some work being done at the property and David Sykes stopped over to check on the work being done. No permits have been pulled in regards to any work for this address. Mr. Sykes had a talk with the contractor for that property and is working to clear this issue. The building has been whitewashed and some demo has been done but no substantial renovation has begun. There has been no end user listed and the building is still owned by IRT who purchased the entire B&W campus.

Mr. Jaber asked if there were any updates on the housing going in off of Rt. 619. The Mayor responded that there have been no updates and that there are weekly update calls being made. Mr. Jaber also asked Mr. Todd Shreve if there were any updates from ODOT regarding the sign on Rt 224 in regards to Barber Road Closures. Mr. Shreve stated that he is completing a research ticket to submit our question to them and they will respond as to how they can help us.
